FIRST NATION HEALTH CENTRE SUPPORTING RECORDS (cEMR)

First Nation Health Centres have a broad range of health services and care providers. Our community partners have indicated it is inefficient and divisive to have multiple “specialist” software systems for each type of service provider. And further, that it is ineffective to try and ‘force-fit’ everyone into using a tool that might only be well suited to a small portion of the team. The Mustimuhw Community Electronic Medical Record (cEMR) is designed to address these challenges.

Mental Wellness

Mental Wellness programs and services are an important focus of the cEMR. Supporting a wide range of standardized forms, assessments & reports for clinical counsellors, A&D and NNADAP workers. Also manages contracted external MW sessions.

Medical Transportation

The Medical Transportation module takes the complexity out of managing transportation benefits and trips. Multiple models of workflow are supported, including van management and scheduling, warrants and vouchers, and financial reconciliation.
